



B at The BRITs 2018 – Full Terms and Conditions

Promoter

1. The promoter of the Clydesdale Bank and Yorkshire Bank BRITs Mastercard prize draw (the "Prize Draw") is Clydesdale Bank PLC (the "Promoter"). Clydesdale Bank PLC is registered in Scotland under company number: SC001111, and has its registered office at 30 St. Vincent Place, Glasgow, G1 2HL.

Participants

2. The Prize Draw is open to B current account or B credit card account holders who are resident in England, Scotland or Wales and who are aged 18 years or over. Employees of the Promoter directly associated with the administration of the Prize Draw or any third party directly associated with the administration of the Prize Draw, are not eligible to participate.
3. The Prize Draw is free to enter.

How to Enter

4. Participants will be automatically entered into the Prize Draw by successfully completing 5 contactless transactions using their B current account or B credit card account Mastercard between 00:00:00 GMT 1st January 2018 to 23:59:59 GMT on 31st January 2018 inclusive (the "Entry Period"). Eligible transactions must be made via contactless, Apple Pay or Android Pay™ transactions and all must be made from the same B current account or B credit card account. There is a maximum of one entry per participant. Where a B current account or B credit card account is held jointly, eligible transactions can be made by any of the account holders but all account holders must be eligible to enter and will be treated as one participant for the purposes of entry into the Prize Draw and, therefore, only eligible to win one prize between them.
5. The Prize Draw will be held on the 8th February 2018 (the "Draw Date") to draw ten winners of a VIP Experience for two at The BRIT Awards 2018 with Mastercard. Each winner will be randomly selected by a computer process from the entries received in accordance with these Terms and Conditions. Any participant drawn as a winner will only be eligible to win where the B current account or B credit card account used for entry is still open when drawn as a winner.

Prizes

6. Ten winners will each receive a VIP Experience for 2 people to The BRIT Awards 2018 with Mastercard comprising:
 - 2 x tickets to The BRIT Awards 2018 in a private suite, on 21st February 2018 at The O2 in London;
 - Pre-show drinks and a fully catered buffet-style dinner in the suite for the winner and their guest;
 - 2 x tickets to the Official BRITs After Show Party;
 - One night's accommodation on 21st February 2018 at the InterContinental London - The O2 for the winner and their guest including breakfast (one bedroom on a double or twin occupancy basis); and
- £300 to spend on travel for the winner and their guest to/from London and/or to/from the BRIT Awards and BRITs After Show Party.
7. Prizes do not include spending money, insurance, tax or personal expenses and do not include the cost of any food and drink not already specified in these Terms and Conditions. Any such costs or any other costs incurred that are incidental to the fulfilment of the prize are the responsibility of the winners.

Winners will be notified by email or telephone within one week of the Draw Date and will have 48 hours from that contact to accept their prize in writing by replying to the winner's email sent to them by the Promoter's agent/supplier. If this time is exceeded, that prize will be forfeited and another winner will be selected at random from remaining valid entries. No responsibility will be accepted by the Promoter for any claims which, for technical or any other reason, are not received or lost.
9. If a winner cannot be contacted due to not having valid or up-to-date contact details held by the Promoter, associated with their B current account or B credit card account, that winner will no longer be eligible for that prize and an alternative winner will be selected at random from remaining valid entries.
10. Winners will receive advance instructions from the Promoter or its agents/suppliers as to how event tickets should be collected. Failure to collect and present the tickets in accordance with those instructions may result in entry being refused.
11. The prizes are as stated, are non-transferrable and cannot be sold or exchanged for cash, goods or services.
12. Mandatory information for the VIP Experience:
 - a) Winners and their guests must be aged 18 or over and photographic identification may be required by the Promoter, event organisers and/or BRIT Award venue(s).
 - b) Prize packages (and associated tickets) are personal to each winner and the sale or offering for sale, transfer, resale, donation, or exchange of any tickets and/or part of any of the prize packages is strictly prohibited (including, without limitation, in person or online via an online auction website or online ticket resale marketplace). The Promoter reserves the right to cancel tickets and withdraw or make void any and all prize elements if this term is not complied with.
 - c) Winners and their guests acknowledge and agree that they are subject to the full terms and conditions of the tickets which form part of their prize, which can be viewed at www.brits.co.uk/terms-and-conditions. These terms and conditions are subject to change from time to time and may include the requirement for ticket holders to present valid photo ID (passport or driving licence) and/or other forms of identification (such as a debit or credit card) upon entry to the event to ensure that the ticket

holder is the same as the person named on their ticket. Failure to comply with any of the terms and conditions may result in refused entry, or the ticket holders being required to leave the event.

- d) It is a condition of entry that winners and their guests agree to take part in any reasonable publicity accompanying or resulting from the Prize Draw, without recompense.
 - e) Winners and their guests acknowledge and agree that they are subject to the full terms and conditions of The O2 (Venue), which can be viewed on the Venue's website, and the Venue reserves the right to remove any person or refuse any person entry to The BRIT Awards 2018 with Mastercard regardless of whether they have a valid ticket.

The Promoter will not be responsible where a winner or their guest is refused entry or re-entry to the BRIT Awards event or After-Show Party due to their behaviour or due to their failure to meet the applicable Terms and Conditions and/or admission criteria of the venue(s). Winners and their guests are each responsible for ensuring they are familiar with Terms and Conditions and admission requirements of the events and venue(s).

Promoter Rights

14. The Promoter reserves the right to cancel, terminate, modify or suspend the Prize Draw or these Terms and Conditions, either in whole or in part, with or without notice. Any updated Terms and Conditions will be made available via all channels used for the promotion of the Prize Draw. Where these Terms and Conditions are amended, the Promoter will make all reasonable endeavours to minimise the effect on participants to avoid undue disappointment.
15. The Promoter reserves the right to substitute the prizes for one of equal or greater value at the choosing and discretion of the Promoter.
16. The Promoter reserves the right to publish the name and/or location of each winner.
17. The Promoter's decision is final in every situation including any not covered above and no correspondence will be entered into. The Promoter reserves the right to investigate any activity it believes to be of a fraudulent nature and to disqualify any participants that it believes are carrying out fraudulent activity or otherwise seeking to circumvent these Terms and Conditions.

General

18. This Prize Draw is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter or Instagram. Facebook, Twitter and Instagram are not responsible to entrants in respect of any aspect of the Prize Draw. By entering the Prize Draw, entrants are providing information to the Promoter and its third party associates contracted for the purpose of administering the Prize Draw and not to Facebook, Twitter or Instagram.
